Physicians with DATA 2000 waivers to prescribe buprenorphine know that they need to have counseling available for their patients, but they may not be aware of the evidence supporting specific psychosocial interventions. Likewise, Opioid Treatment Programs know that counseling and case management services are important, but they may not be aware of which specific psychosocial interventions have the best evidence supporting them. Others may not appreciate the strength of evidence supporting medication for treatment of Opioid Use Disorders (OUD).

This session will provide an overview of the evidence supporting the VA-Department of Defense Clinical Practice Guideline for Management of Substance Use Disorders and specific recommendations relevant to opioid use disorder care. Discussion will focus on anticipating barriers to evidence-based treatment of OUD.
