## Dear Congresswoman Underwood:

On behalf of the more than 590,000 physicians and medical students represented by the combined memberships of the American Academy of Family Physicians, the American Academy of Pediatrics, the American College of Obstetricians and Gynecologists, the American College of Physicians, the American Osteopathic Association, and the American Psychiatric Association, we write to express our support for the *Primary and Behavioral Health Care Access Act* (HR 5575).

As organizations that represent the frontline physicians who provide the overwhelming majority of care to our nation's children, women, adults and elderly for a full-range of physical, mental and behavioral health conditions, we recognize the need for reforms to address ongoing barriers to care. When faced with high deductibles and out-of-pocket costs, many Americans are skipping or delaying care<sup>12345</sup>. When patients skip visits to their primary care or behavioral health provider, it can lead to conditions going undetected or unmanaged, worsening illness, and costlier future encounters with the health care system.

By ensuring that individuals have access to three primary care visits and three behavioral health visits, independent of cost-sharing requirements, your legislation helps to eliminate economic barriers to care and strengthen the physician-patient relationship. Your legislation also recognizes that mental health is an essential part of overall health and well-being. Our joint principles call for addressing cost barriers and ensuring parity between medical and mental health benefits.

Increased access to primary care and behavioral health care has also been shown to reduce overall health care costs<sup>67</sup>.

Thank you for your leadership. We look forward to working with you to advance this legislation and to improve access to meaningful health coverage.
