# **Special Presidential Commendation**

A aron T. Beck, M.D., is President Emeritus of the non-profit Beck Institute for Cognitive Behavior Therapy and Professor Emeritus in Psychiatry at the University of Pennsylvania. Dr. Beck is globally recognized as the father of Cognitive Behavior Therapy (CBT), having developed this revolutionary treatment in the 1960s and 1970s. His latest work has focused on Recovery-Oriented Cognitive Therapy for individuals diagnosed with serious mental health conditions. Dr. Beck has published over 600 articles

and authored or co-authored 25 books, and is the recipient of numerous awards, including the Albert Lasker Award for Clinical Medical Research and the Gustave O. Lienhard Award from the Institute of Medicine.

Renee Binder, M.D., is a Distinguished Professor of Psychiatry, the Founding Director of the Psychiatry and Law Program and Forensic Psychiatry Fellowship, and Associate Dean for Academic Affairs at the University of California, San Francisco, School of Medicine (UCSF). She served as interim Chair of the Department of Psychiatry at UCSF and has also served as President of the American Psychiatric Association. During her APA presidential year, Dr. Binder focused on advocacy for decriminalization of persons with mental illness.

During this past year, Dr. Binder has served the APA as a member of the Presidential Task Force on Structural Racism.

David Fassler, M.D., is a child and adolescent psychiatrist practicing in Burlington, Vermont. A graduate of Yale University School of Medicine, he completed his training in adult psychiatry at the University of Vermont, and in child psychiatry at Cambridge Hospital. He is the clinical director of Otter Creek Associates, a multidisciplinary practice providing comprehensive mental health and substance abuse treatment services. He is also a Clinical Professor of Psychiatry at the Larner College of Medicine at the University of Vermont

and the Director of Advocacy and Public Policy at the Vermont Center for Children, Youth & Families.





Roberto Lewis-Fernández, M.D., is Professor of Clinical Psychiatry at Columbia University, Director of the NYS Center of Excellence for Cultural Competence and the Hispanic Treatment Program, and Co-Director of the Anxiety Disorder Clinic, at NYS Psychiatric Institute. His research focuses on developing culturally-valid interventions to enhance patient engagement, reduce misdiagnosis, and help overcome disparities in the care of underserved cultural groups. He has published widely in forensic and cultural psychiatry. He authored *Belonging, Therapeutic Landscapes, and Networks* in 2018. Nash, M.D., is a Professor at the University of Pittsburgh School of Medicine, the Vice Chair for Clinical Affairs of Psychiatry, Interim Chief of Clinical Affairs of Neurology, and the Chief of Clinical Services at UPMC Western Psychiatric Hospital. He directs over 200 psychiatrists, 434 inpatient psychiatry beds, consultations services, and over 85 ambulatory programs. Dr. Nash is a leader in transforming the way behavioral health services are provided through innovative models of care and is the consulting psychiatrist to the Pittsburgh Steelers and Pittsburgh Penguins.



Paul S. Appelbaum, M.D., is the Dollard Professor of Psychiatry, Medicine, and Law, and Director, Center for Law, Ethics, and Psychiatry, Department of Psychiatry, Columbia University. He directs Columbia's Center for Research on Ethical, Legal, & Social Implications of Psychiatric, Neurologic, & Behavioral Genetics. The author of many articles and books on law and ethics in clinical practice and research, he is a Past President of the APA and chairs the DSM Steering Committee. A graduate of Columbia College and Harvard Medical School, he has been elected to the National Academy of Medicine.

Craig A. Erickson, M.D., is a Professor of Psychiatry at Cincinnati Children's Hospital Medical Center and the University of Cincinnati College of Medicine-Affiliated. Dr. Erickson leads a neurodevelopmental clinical and research group focused on improving clinical care through research discovery. He is the Director of the Cincinnati Fragile X Research and Treatment Center which is the third largest such program in the world. He serves as the Chair of the Clinical Trials Committee organized by the National Fragile X Foundation and

#### John Fryer Award

The John Fryer Award, established in 2005, honors an individual who has contributed to improving the mental health of sexual minorities. The award is named for Dr. John Fryer, a gay psychiatrist who played a crucial role in prompting APA to review the scientific data and to remove homosexuality from its diagnostic list of mental disorders in 1973.




