The **Collaborative Care Model** integrates effective psychiatric care into primary care practices. It is the only integrated care model with a clear evidence base and has been tested in more than 80 randomized trials. Collaborative Care uses a team-based approach to address care for the ‘whole person.’ The care team consists of a **behavioral health care manager**, **psychiatric consultant**, and a **primary care provider (PCP)**.

The training, led by John Kern, MD from the University of Washington’s AIMS Center, will provide participants with the practical skills to work in collaborative care. The course describes the delivery of mental health care in primary care settings with a focus on the evidence-base, guiding principles, and an introduction to implementation strategies.

In addition to the training, there will be guest speakers from a Yale practice that is preparing to implement the model, an expert speaker on telemedicine to include best practices and current trends and a special presentation on VA experiences in both integrated care and telepsychiatry.

**The registration fee for the conference is \$40**, covering the cost of attendees’ continental breakfast and boxed lunch provided during the event. The Collaborative Care training is provided as a result of APA’s participation in the Transforming Clinical Practice Initiative (TCPi) supported by CMS, and **participation is open to Psychiatrists, Primary Care Physicians, Residents and Medical Students, and Behavioral Health Care Managers.**
