Dear Chairwoman Collins, Vice Chair Murray, Subcommittee Chairwoman Capito, and Subcommittee Ranking Member Baldwin:

On behalf of the **132** undersigned national, regional and local organizations in the maternal, child, and mental health space who support the health and wellbeing of pregnant and new mothers, we thank you for including \$12 million for the Screening and Treatment for Maternal Mental Health and Substance Use Disorder State Grant Program (HRSA State Grant), \$8 million for the Maternal Mental Health Hotline, and report language to help mothers in tribal communities and our brave servicewomen within your FY 2026 LHHS package. Your leadership preserves and protects life-saving maternal mental health resources and improves perinatal psychiatric access for millions of women suffering from maternal mental health conditions nationwide.

While we applaud and sincerely appreciate the increased funding for both programs, **we respectfully request that you match the \$13.5 million funding level included in the House Appropriations Committee-passed package for Screening and Treatment for Maternal Mental Health and Substance Use Disorders state grant program.** Two-thirds of states have sought HRSA State grant funds, but only one-fourth received funding. The additional \$1.5 million would fund at least two new states or tribal communities to expand maternal mental health screening and treatment for pregnant and new mothers in need.

Recently, the CDC using data from maternal mortality review committees, found that 22.5% of pregnancy-related deaths were attributed to underlying mental health conditions, including depression, anxiety, bipolar and other mental health conditions, and most notably, substance use disorder, which was responsible for 63.3% of mental-health-attributed pregnancy-related deaths in 2021.¹ This data reaffirms the urgency in addressing our nation's maternal mortality rate and the need to ensure all mothers have access to the maternal mental health resources they so desperately need.

On behalf of the 4 million mothers who give birth in the United States every year, we thank you for your continuous support for mothers and attention to this critical matter.
