

Program Format Descriptions

Courses

Courses provide enriched learning experiences that actively involve participants and include the opportunity for informal exchange with faculty. Offered in four-hour (half-day), six-hour (full-day) and eight-hour (full-day) sessions, courses either review basic concepts in a special subject area or present advanced material on a circumscribed topic. Additional registration is required to participate in all courses.

Forums

Forums are flexible 90-minute presentations that afford participants the opportunity to highlight timely topics of interest to psychiatrists. Speakers and panel members are chosen for their expertise and leadership in the field.

Learning Lab

The Learning Lab introduces an exciting new way to learn at the IPS Conference. Each session in the Learning Lab transforms learning through collaboration, rich discussion around issues impacting psychiatry and hands-on learning.

Lectures

Lectures feature a small number of distinguished speakers discussing scientific and cultural topics, many of which will extend our understanding beyond the usual limits of clinical psychiatry. The Scientific Program Committee invites the lecturers to present as part of the scientific program.

LECTURER BIOS



Lt. Gen. Mark Hertling (Ret.)

Leaving his beloved U.S. Army in January 2013, Lt. Gen. Mark Hertling (Ret.) is now leading programs for global partnering, leadership development, and health performance strategies at the innovative Florida Hospital in Orlando.

Prior to joining Florida Hospital, Mark served for almost four decades in the U.S. Army. At

the time of his retirement, he was commanding general of U.S. Army Europe, where he led over 50,000 soldiers, cared for over 100,000 family members, and partnered with the armies of 50 countries in the European theater. During his military career, Lt. Gen. Hertling commanded training organizations at the Army's National Training Center (Ft. Irwin, California) and the Joint Multi-National Training Center (Grafenwoehr, Germany). He was an assistant division commander in Baghdad in 2003-4 and later commanded the Army's 1st Armored Division (1AD) in Germany and in Northern Iraq during the surge. Hertling spent over 36 months in combat.

Receiving a Bachelor of Science from the U.S. Military Academy in 1975, Lt. Gen. Hertling is a graduate of the Army's Staff College, the School of Advanced Military Studies, and the National War College. He also holds master's degrees in history and international relations from these institutions, and he also earned a master's degree in exercise physiology from Indiana University. He is currently pursuing an executive doctorate in business administration from the Crummer School at Rollins College.

During his time in the Army, Mark received many military honors, including three awards of the Distinguished Service Medal, six awards of the Legion of Merit, five Bronze Stars, a Purple Heart, and the Army Commendation Medal for Valor. He also received the Gold Cross of Honor of the German Army, the Romanian Land Forces Emblem of Honor, and the Polish Soldier's Medal of Honor. He is a life member of the Purple Heart Association, Phi Kappa Phi, and he is a Distinguished Eagle Scout. In 2015, he received the Dwight D. Eisenhower Award from the U.S. Sports Academy.

In addition to working with Florida Hospital, Mark was appointed by President Obama and served for four years as one of 25 members of the President's Council on Fitness, Sport, and Nutrition. He is an adjunct scholar at West Point's Modern War Institute, and he also serves as a military analyst for CNN. LECTURER BIOS



Ann Marie T. Sullivan, M.D.,

Dr. Ann Marie T. Sullivan was confirmed by the New York State Senate as Commissioner for the New York State Office of Mental Health on June 20, 2014. New York State has a large, multi-faceted mental health system that serves more than 700,000 individuals each year. The Office of Mental Health (OMH) operates psychiatric centers across the State, and also oversees more than 4,500 community programs, including inpatient and outpatient programs, emergency, community support, residential and family care programs. As Commissioner, she has guided the transformation of the state hospital system in its emphasis on recovery and expansion of community based treatment, reinvesting over 60 million dollars in community services. Working closely with all mental health providers and health plans, she is responsible for the movement of the health benefit for the seriously mentally ill into managed care beginning October 2015. This new Health and Recovery Plan (HARP) benefit will embed in the Medicaid benefit critical recovery services such as crisis respite, peer, educational and employment supports. She has also been instrumental in expanding services for the mentally ill in prisons and in expanding the much needed community based continuum of care for the seriously mentally ill leaving prison and returning to their community.

Previously, she was the Senior Vice President for the Queens Health Network of the New York City Health and Hospitals Corporation. As Senior Vice President, she was responsible for Elmhurst and Queens Hospital Centers, two public hospitals which serve a community of over 2 million New York City residents. Along with ensuring the seamless integration and coordination of services across the Network, Dr. Sullivan aligned and helped to implement key corporate programs such as the Care Management Initiative on the inpatient units and in the emergency services; the launching of best practices to improve patient safety; and the integration of behavioral health and medical services. Dr. Sullivan grew up in Queens, New York City. She graduated from NYU and its School of Medicine and completed her Psychiatric Residency at New York University/Bellevue Hospital in 1978. She has served as Associate Director of Psychiatry and Medical Director of Ambulatory Care at the Gouverneur Diagnostic and Treatment Center and joined the Queens Health Network as Regional Director of Psychiatry in 1990, overseeing the administrative, budgetary, and clinical aspects of the psychiatric services of both Network hospitals. She has enjoyed an extensive career in public psychiatry and has lectured and published on best practices in community care.

Dr. Sullivan is an active advocate for her patients and her profession, is a Distinguished Fellow of the American Psychiatric Association and has served as the Speaker of the American Psychiatric Association's Assembly and on its Board of Trustees. She is a fellow of the New York Academy of Medicine, a member of the American College of Psychiatrists and the Group for the Advancement of Psychiatry.

Jean-Marie Bradford, M.D.,

is the director of the Washington Heights Community Service at the New York State Psychiatric Institute and an assistant clinical professor of psychiatry in the department of psychiatry of the College of Physicians and Surgeons at Columbia University. As WHCS director, she manages an inpatient unit, two community outpatient clinics, and a firstepisode psychosis treatment program, OnTrackNY/WHCS. Dr. Bradford is currently working on expanding integrated care on WHCS. Dr. Bradford also serves as the training director for the Columbia University Global Mental Health T32 Research Fellowship and the co-chair for the Columbia University Department of Psychiatry Committee for Diversity and Inclusion and eniovs teaching and supervising trainees. She co-teaches the course "Models of Integrating Systems of Care," serves as a mentor and clinical supervisor for medical students and Columbia psychiatry residents in supportive psychotherapy and public psychiatry. Dr. Bradford's professional interests include improving psychiatric care for the severely mentally ill in underserved communities in the U.S. and abroad, teaching, faculty development, and issues of diversity and inclusion.



Nancy Byatt, D.O, M.B.A., M.S.,

is a psychiatrist, physicianscientist, and perinatal mental health expert focused on improving health care systems to promote maternal mental health. She is an associate professor of psychiatry and obstetrics and gynecology at the University of Massachusetts Medical School. She is the inaugural statewide medical director of MCPAP for Moms, a statewide program that addresses perinatal mental health and substance use disorders in Massachusetts by providing mental health consultation and care coordination for medical providers serving pregnant and postpartum women. She has been awarded several federal grants for her research, which aims to ensure that pregnant and postpartum women with depression receive optimal mental health treatment. She frequently serves on national advisory boards and expert work groups focused on improving perinatal mental health. Her academic achievements have led to over 60 peer-reviewed publications and national presentations and numerous national awards.



Nancy Harvey, L.M.S.W.,

has served as the chief executive officer of Service Program for Older People (SPOP) in New York City since 1990. During her tenure, SPOP has grown from a neighborhood-based mental health agency serving older adults to a borough-wide resource for affordable behavioral health care for adults age 55 and older. A graduate of the State University of New York system, she holds a B.A. from SUNY New Paltz and an M.S.W. from SUNY Albany. She has been an advocate for increasing access to geriatric mental health care in the region and has worked in partnership with the NYC Department of Health and Mental Hygiene, NYC Department for the Aging, Mount Sinai Hospital, SAGE/Services and Advocacy for GLBT Elders, VISIONS/ Services for the Blind and Visually Impaired, and dozens of other organizations. She is currently a member of the board of directors of The Coalition of for Behavioral Health in New York City and has served on numerous other nonprofit boards over the years. Her entire career has been committed to serving older adults.

David Kaye, M.D.,

is professor of psychiatry and vice chair for academic affairs at the University at Buffalo (UB) Jacobs School of Medicine and Biomedical Sciences. He established the residency training program in child/adolescent psychiatry at UB and served as director of training from 1986 to 2014. Since 2010, he has led the Child and Adolescent Psychiatry for Primary Care (CAP PC) program, providing education and consultation support for primary care providers. He is a distinguished fellow of AACAP, a distinguished life fellow of the American Psychiatric Association, and a past president of the American Association of Directors of Psychiatric Residency Training. His work and writing has focused on psychiatric education, and he is first author on a book for primary care physicians: Child and Adolescent Mental Health. CAP PC represents a lifetime of working toward the integration of physical and mental health, in his heart from the beginning of medical school.



Charles H. Kellner, M.D.,

is professor of psychiatry and director of the division of geriatric psychiatry at the Mount Sinai School of Medicine and director of the ECT service at the Mount Sinai Hospital. Dr. Kellner received his M.D. from Cornell University Medical College. He did his internship at Los Angeles County Medical Center and his psychiatry residency at Cedars-Sinai Medical Center. He did a fellowship in biological psychiatry at the National Institute of Mental Health in Bethesda, Maryland. He was on the faculty of the Medical University of South Carolina in Charleston from 1984 to 2002, where he directed the ECT service. He was chair of the department of psychiatry at New Jersey Medical School from 2002 to 2008 and director of the ECT service at University Hospital in Newark. He has dedicated his career to the study of ECT and is editor emeritus of the Journal of ECT. He has led the collaborative ECT research group CORE (Consortium for Research in ECT) for the past decade in the performance of NIMH-sponsored multisite research protocols. He has over 150 publications, most related to ECT and mood disorders. He has authored the APA published text, Handbook of ECT. He is a member of the APA task force on ECT, currently revising the APA recommendations on ECT.



Kerry J. Ressler, M.D., Ph.D.,

is chief scientific officer at McLean Hospital and professor of psychiatry at the Harvard Medical School. He received his undergraduate degree from MIT and his M.D./Ph.D. from Harvard Medical School. Dr. Ressler began at McLean Hospital in August 2015 after 18 years at Emory University in Atlanta, where he studied epigenetic mechanisms and the neural basis of trauma exposure in at-risk, low socioeconomic populations in inner-city Atlanta. There, he led a team to understand mechanisms of trauma and to identify new ways to improve interventions and awareness for at-risk civilians. Dr. Ressler is a former Howard Hughes Medical Institute Investigator, a member of the National Academy of Medicine, and the 2017 president of the Society for Biological Psychiatry. His work focuses on translational research bridging molecular neurobiology with genetic research on emotion, particularly fear and anxiety disorders.


